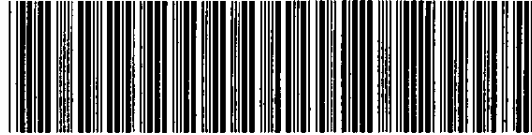

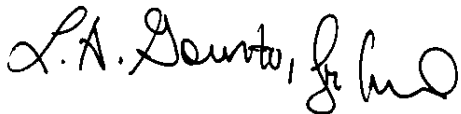

ARTICLE 1
NAME

The name of this limited liability company is Lightco Management, LLC.

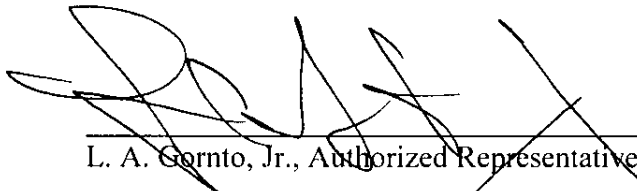

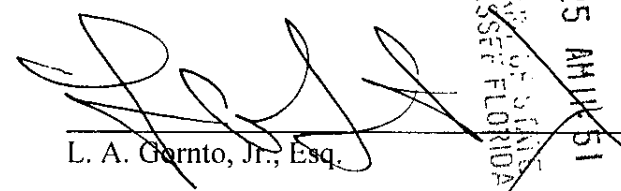
