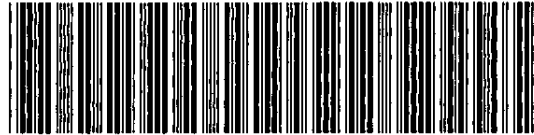

**ARTICLES OF ORGANIZATION
OF**

NutraApex LLC

ARTICLE I
NAME

The name of this limited liability company (the "Company") shall be **NutraApex LLC** and its mailing address and principal place of business is 4521 PGA Boulevard, Suite 251, Palm Beach Gardens, Florida 33418.

ARTICLE II
COMMENCEMENT OF COMPANY EXISTENCE

This Company shall commence existence on the date these Articles of Organization are filed with the Division of Corporations of the Florida Department of State and shall have perpetual existence unless sooner dissolved according to its Operating Agreement or law.

ARTICLE III
PURPOSE AND POWERS

This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

ARTICLE IV
INITIAL REGISTERED OFFICE AND AGENT

The initial name and address of the registered agent of this Company is Daniel Roselli, 2135 South Congress Avenue, Suite 1C, West Palm Beach, Florida 33406-7611. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

ARTICLE V
MANAGEMENT

The Company shall be managed by a Manager or Managers as set forth in the Operating Agreement adopted by the Company. The Manager or Managers' authority to manage the Company and to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business shall be as described in the Operating Agreement.

ARTICLE VI
AMENDMENT

The right to amend or repeal any provision contained in these Articles of Organization, or any amendment hereto, is conferred upon the Manager or Managers.

ARTICLE VII
HEADINGS AND CAPTIONS

The headings or captions of these Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.

ARTICLE VIII
RELATIONSHIP OF ARTICLES OF ORGANIZATION
TO OPERATING AGREEMENT

If a provision of these Articles of Organization differs from a provision of the Company's Operating Agreement, then, to the extent allowed by law, the Operating Agreement will govern.

IN WITNESS WHEREOF, the undersigned authorized representative of the Company does hereby make and file these Articles of Organization declaring and certifying that the facts stated herein are true, this 25th day of July, 2008.
