ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under Ch. 608 of the laws of Florida, hereby adopts the following Articles of Organization.

ARTICLE 1 - NAME

The name of the Company is **INCREDIBLE WASTEWATER TREATMENT CHEMICALS, LLC.** The mailing address of the principal office is: 2850 First Avenue, Fernandina Beach, Florida 32034, with a street address of the same. This shall not be construed as a limitation on the number or address of business locations.

ARTICLE II - DURATION
