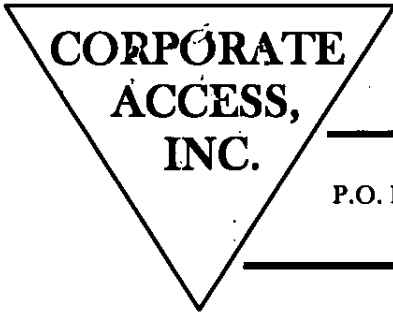

### **MEMBERS RIGHTS TO CONTINUE BUSINESS**

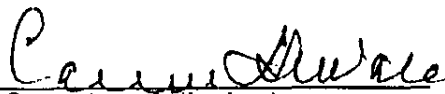
