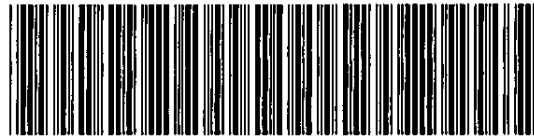


ARTICLE 6

Admission of Additional Members



additional members.






