ARTICLES OF ORGANIZATION

OF

COMPUTER WORKS OF TUSCAWILLA, LLC

I, the undersigned, being the Member and Organizer of the Limited Liability Company hereby being formed under Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for the Limited Liability Company for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I: NAME

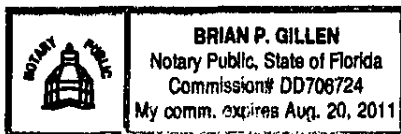
