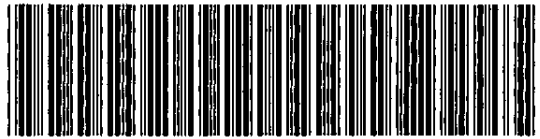



3. The dissolution was approved December 30, 2008.




5. All debts, obligations and liabilities of the limited liability company have been paid or discharged.
