# **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

# **ARTICLE 1 - NAME**

The name of the limited liability company shall be TELEFONIA GLOBAL ILIMITADA, LLC ("Company").

# ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 5401 North Haverhill Road, Suite 105, West Palm Beach, Florida 33407 and the mailing address shall be the same.

### ARTICLE 3 - EFFECTIVE DATE

If any word, clause or sentence of the foregoing provisions regarding Indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected.
