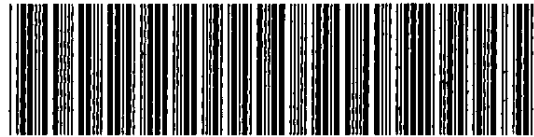

ARTICLES OF ORGANIZATION
OF
CONDRA-DONN.COM, L.L.C.

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

ARTICLE I
Name

The name of the limited liability company is CONDRA-DONN.COM, L.L.C. (hereinafter referred to as the "Company").

ARTICLE II
Period of Duration

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

ARTICLE III
Purpose

The purpose for which the Company is organized is to engage in creation, leasing, sale, licensing, branding, display and ownership of artwork, paintings, sculptures, images, writings, designs, and films and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida.
