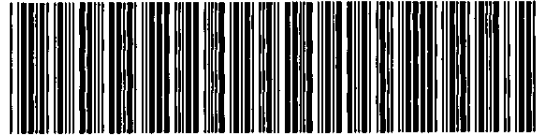


**ARTICLE VI**
