# ARTICLES OF ORGANIZATION

OF

#### LAKE NONA MEDICAL CITY, LLC

The undersigned, acting as the organizer of Lake Nona Medical City, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

# **ARTICLE I - Name:**

The name of the limited liability company is Lake Nona Medical City, LLC (the "Company").

## **ARTICLE II - Address:**

The mailing address and the street address of the Company is 9801 Lake Nona Road, Orlando, Florida 32827.

## ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization or Chapter 608, Fla. Stat.

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated in accordance with the terms of the Operating Agreement of the Company.

Unless dissolved in accordance with the Company's Operating Agreement, the remaining members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member.
