Pursuant to the provisions of section 608.411, Florida Statutes, URBANA PELICAN GRAND I LLC, adopts the following amendment to its Articles of Organization:

FIRST: The name of this Florida limited liability company as filed with the Florida Department of State is URBANA PELICAN GRAND I LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on August 6, 2008 and assigned Document Number L08000075447.

THIRD: Article 4 of the Articles of Organization of the Company is amended to revert the governance of the Company to being manager-managed and, in accordance therewith, Article 4 is amended in its entirety to read as follows:

**"ARTICLE 4
MANAGEMENT AND MEMBERS**

The limited liability company has two members: (1) Urbana Pelican Investor LLC, a Florida limited liability company and (2) Jefast Hotel, LLC, a Florida limited liability company. The limited liability company will be managed by a Non-Member Manager. The Non-Member Manager is Urbana Pelican Manager LLC, a Florida limited liability company, whose address is c/o Allan Gutierrez, 1420 Peachtree Street, NE, Suite 250, Atlanta, GA 30309."

FOURTH: Except as amended above, the Articles of Organization of the Company, as filed with the Florida Department of State, shall remain in full force and effect.

FIFTH: The foregoing amendment was approved on November 22, 2011 by written consent of the members owning 90% of the membership interests in the Company.


