**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
FOR

(A Florida Limited Liability Company)**

Pursuant to the provisions of section 608.411, Florida Statutes, Jefast Pelican Grand I LLC adopts the following amendment and restatement to its Articles of Organization, which were originally filed under the name "Urbana Pelican Grand I LLC" on August 6, 2008 and assigned Document Number L08000075447.

**ARTICLE I -
Name**

The name of the Limited Liability Company is Jefast Pelican Grand I LLC (the "Company").

**ARTICLE II -
Duration**

The existence of the Company commenced upon the filing of the Articles of Organization with the Secretary of State of the State of Florida on August 6, 2008. The duration of the Company shall be perpetual.

**ARTICLE III -
Nature of Business**

The Company's business and purpose shall consist solely of the acquisition, ownership, operation and management of the real estate project known as the Pelican Grand Beach Resort, located in Fort Lauderdale, Florida (the "Property"), and to engage in such other lawful activities permitted to limited liability companies by the Florida Limited Liability Company Act as are necessary, incidental or appropriate in connection therewith.

Membership Certificates**


