**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State the following are the Articles of Organization for MSP RENTAL OF CENTRAL FLORIDA, LLC (the "Company"):

1. Name. The name of the Company is MSP RENTAL OF CENTRAL FLORIDA, LLC.


