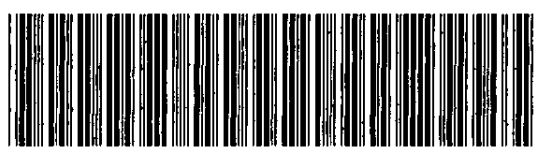

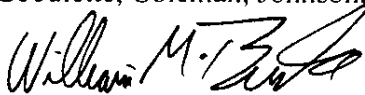

Article 1. Name

The name of the Limited Liability Company is:

TCN Capital Investments, LLC

Article 2. Initial Principal Office

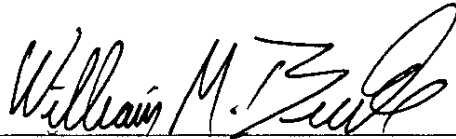
