ARTICLES OF ORGANIZATION

ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS

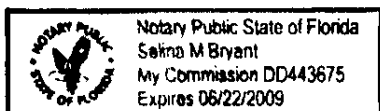

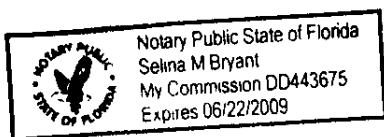
