ARTICLES OF ORGANIZATION OF

PALMS WEST MEDICAL MALL 123, LLC

These Articles of Organization of PALMS WEST MEDICAL MALL 123, LLC (the "Company"), have been duly executed and are being filed by the undersigned member to form a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608) as follows:

ARTICLE I

The name of the limited liability company formed hereby is PALMS WEST MEDICAL MALL 123, LLC.

ARTICLE II ADDRESS
