**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF ORGANIZATION  
OF  
COASTAL ANESTHESIOLOGY CONSULTANTS, P.L.**

Coastal Anesthesiology Consultants, P.L., a Florida limited liability company (the "Company"), hereby amends its Articles of Organization for the purposes set forth below in accordance with Florida Statutes Section 605.0202:

1. The Articles of Organization for the Company were filed on August 13, 2008, and amended on September 25, 2009, and further amended on November 16, 2011, under the name of Coastal Anesthesiology Consultants, P.L. and assigned Document No. L08000077561 (the "Company").
2. Article I of the Articles of Organization is hereby deleted in its entirety and replaced with the following:

**ARTICLE I - NAME**

The name of the Company shall be Coastal Anesthesiology Consultants, LLC (the "Company").

3. A new Article VI is hereby added to the Articles of Organization as follows:

**ARTICLE VI - PURPOSE**

The Company is organized for the purpose of transacting any or all business permitted under the Florida Limited Liability Company Act of the State of Florida.

4. The Articles of Amendment to the Articles of Organization were adopted by all of the managers of the Company as of June 30, 2015 in the manner prescribed by Section 605, Florida Statutes.
5. All of the provisions of the Articles of Organization not amended herein are hereby ratified, confirmed, and shall remain unchanged.
6. The foregoing Articles of Amendment to the Articles of Organization of the Company shall be effective as of July 1, 2015.
