

ARTICLE I - NAME

ARTICLE VII - ADMISSION OF NEW MEMBERS

These Articles of Organization may be amended in accordance with the Florida Limited Liability Company Act.

ARTICLE XI - MEMBERS RIGHT TO CONTINUE BUSINESS
