# LIMITED LIABILITY COMPANY OPERATING AGREEMENT FOR MONTANA PTNRS, LLC A MANAGER-MANAGED LIMITED LIABILITY COMPANY

## **Amendment**

#### - ARTICLE I

- 1.4 TERM. The Company shall continue until the December 31, 2022 unless dissolved by:
  - (a) Unanimous vote by all Members for dissolution;

- (c) Any other event causing dissolution of a Limited Liability Company under the laws of the State of Florida.

#### **ARTICLE 2**

#### **Capital Contributions**
