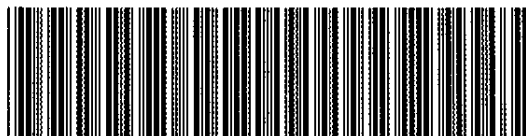

**Introduction and Preliminary Statements**

**Section 1.01 Name**
