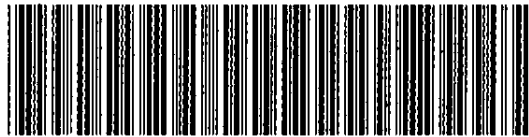

The undersigned, being desirous of forming a professional limited liability company pursuant to Chapter 608, Florida Statutes, hereby certifies as follows:

1. Name of Limited Liability Company. The name of the limited liability company is **HUNT CLUB MEDI-SPA, LLC** a Florida professional limited liability company (the "Company").

2. Period of Duration. The period of duration for the Company shall be perpetual.

3. Principal Office. The mailing address and street address of the principal office of the Company shall be 425 S. Hunt Club Blvd., Suite 1001, Apopka, Florida 32703.

4. Purpose. The purpose of the Company is to own and operate a medical office and to conduct and transact any and all lawful business authorized and not prohibited by the Florida Business Corporation Act, as the same may be, from time to time, amended.



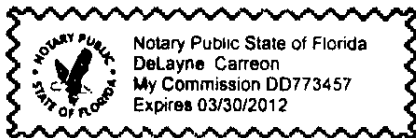
