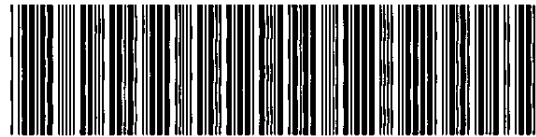

**ARTICLES OF ORGANIZATION
OF
SAV AESTHETICS, LLC**

The undersigned, acting as the initial member of the above-captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is SAV Aesthetics, LLC (the "Company"), and its principal office and mailing address is 3200 S. HIAWASSEE ROAD, SUITE 203, ORLANDO FL 32835.

ARTICLE II - EFFECTIVE DATE; DURATION

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

ARTICLE III - PURPOSE OF ORGANIZATION

The Company is organized for the purpose of enabling its members to engage in any business or other lawful activity that may be engaged in by a limited liability company organized under Florida law. Without in any way limiting the foregoing, the Company may do all other acts and things which may be necessary, appropriate or incidental to the carrying out of the business and purposes of the Company.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

The name and street address of the initial Registered Agent of the Company shall be:

ARTICLE V - MANAGEMENT OF THE COMPANY

The Company shall be managed by a Manager in the manner set forth in the Company's Operating Agreement. The initial Manager shall be Antonio R. Velardi, who shall serve until the earlier of his death, resignation, or replacement by a vote of the members.


ARTICLE VI - OPERATING AGREEMENT

The power to adopt, alter, amend or repeal an Operating Agreement governing the operation of the Company shall be vested in its members.

ARTICLE VII - INDEMNIFICATION

If the criteria set forth in §608.4363, *Florida Statutes*, or any successor statute, and the Company's Operating Agreement have been met, then the Company shall indemnify any manager or member, or former manager or member, his, her or its personal representatives, devisees or heirs, in the manner and to the extent contemplated by §608.4363, *Florida Statutes*.
