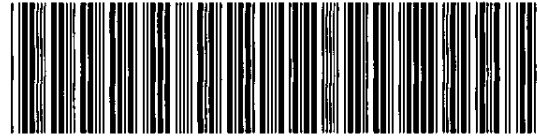

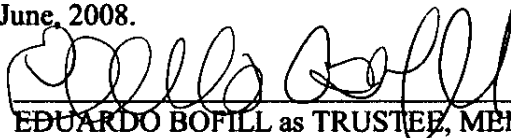
ARTICLE V INITIAL REGISTERED AGENT

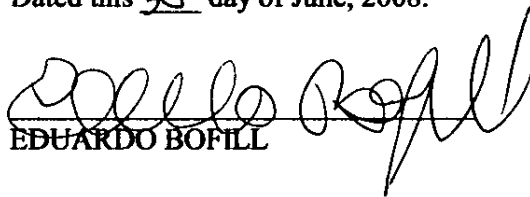
