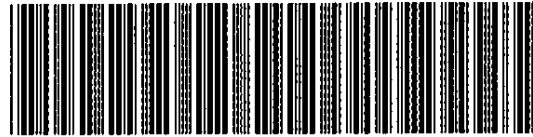

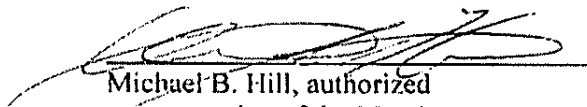
## **Article Four Management and Purpose**

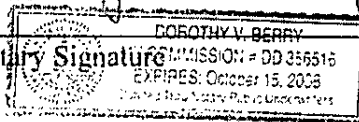
