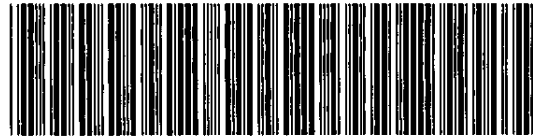


Pursuant to the provisions of section 608.411, Florida Statutes, this Florida limited liability company adopts these Articles of Amendment.
