Pursuant to the provisions of Section 605,1025 of the Florida Statutes, the undersigned hereby adopt the following Articles of Merger:

ARTICLE 1- PLAN OF MERGER

The Plan of Merger of NORTHWESTERN AVENUE, LLC, a Florida limited liability company (the "Company"), document number L08000079159, with and into PWJWII, LLC, a Florida limited liability company (the "LLC"), with the LLC being the surviving entity, is set forth below:

- 1. The Company shall merge with and into the LLC, with the LLC as the surviving entity.
- 2. Upon the consummation of the merger of the Company with and into the LLC, the separate existence of the Company shall cease. The LLC, as the surviving limited liability company, shall continue to exist by virtue of the laws of the State of Florida.
