Operating Agreement

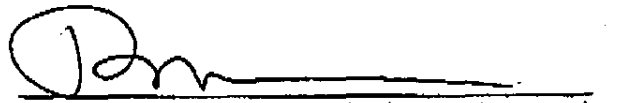
