**ARTICLES OF ORGANIZATION  
OF

**1. NAME.** The name of this limited liability company is CAY LAKEVIEW, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


**2. PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 6654 – 78th Avenue North, Pinellas Park, Florida 33781.
