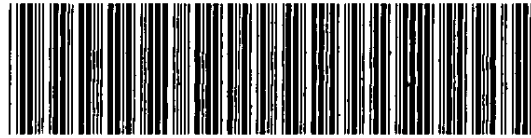



ARTICLE I - Name

The name of the Limited Liability Company is: **J & J Caulking LLC**

ARTICLE II - Address

John C O'Gradney who serves as Manager and who resides at 561 21st Street SW Naples, FL 34117 and:




