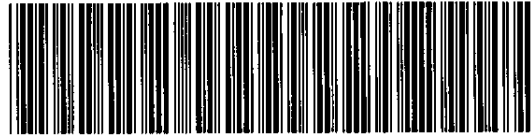

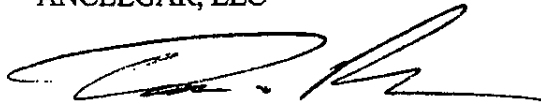
ARTICLE V

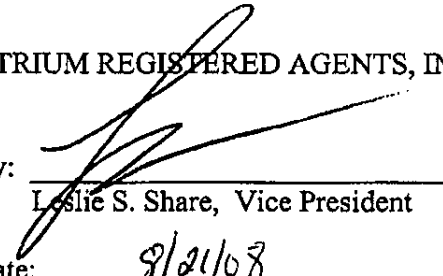
