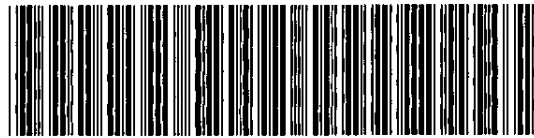

Pursuant to Section 608.407 of the Florida Limited Liability Company Act, the undersigned, as the authorized representative of Kevin Carlson, a Member of Lazers Edge, LLC (hereinafter the "Limited Liability Company"), does hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming a Limited Liability Company under the Laws of the State of Florida.

ARTICLE I. NAME

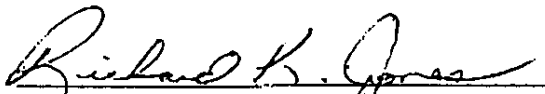
CERTIFICATE OF DESIGNATION OF
