ARTICLES OF ORGANIZATION

The undersigned incorporator, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I NAME

ARTICLE VIII ADMISSION OF NEW MEMBERS


