ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act,

Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE V. REGISTERED AGENT AND OFFICE

The Company designates 9700 South Dixle Highway, Suite 1030, Miami, Florida 33156, its the street address of the initial registered office of the Company and names Myron M. Samole the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE VI. ADDITIONAL MEMBERS

If a provision of these Articles of Organizau on differs from a provision of the Company's Operating Agreement, then, to the extent permitted by law, the Operating Agreement will govern.
