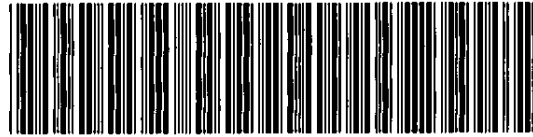

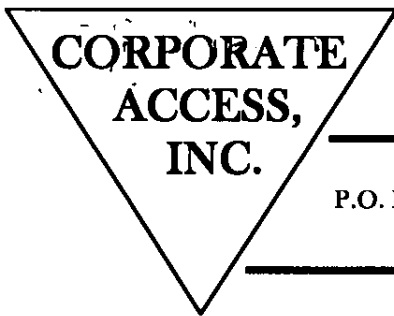

**ARTICLES OF ORGANIZATION
OF**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under Florida Statutes, §§ 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST, the name of the Limited Liability Company is:

GREY DOGS AVIATION, LLC

SECOND, the latest date on which the Limited Liability Company is to dissolve is July 1, 2058.

THIRD, The Limited Liability Company is organized to own, operate for hire and lease an airplane; to own, build and lease a hangar for airplanes; to operate a travel agency; and to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with Florida Statutes, §§ 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH, the street address of the initial registered office of the Limited Liability Company in Florida is: 1250 W. 
