2. The date of filing the Articles of Organization of the Company was August 25, 2008, and assigned document number L08000080838.

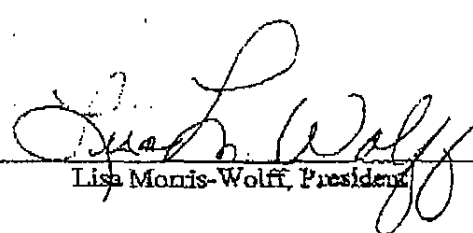
