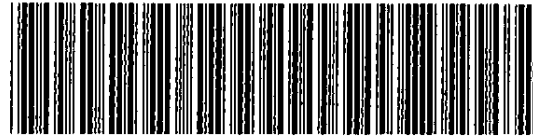




ARTICLE IX




