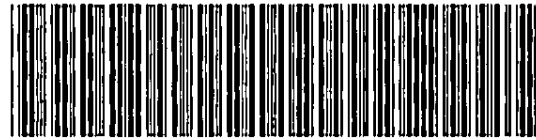

1. Name. The name of the limited liability company is "HOOPER INVESTMENTS, LLC."

5. Provision for Liabilities. All debts, obligations and liabilities of the limited liability company have been paid or discharged.

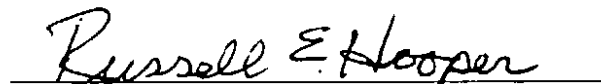
6. Remaining Property. All remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
