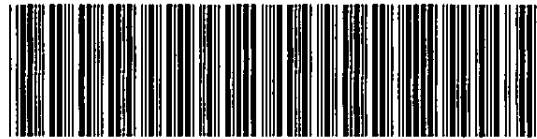

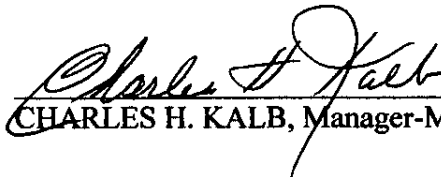
ARTICLE I – NAME
