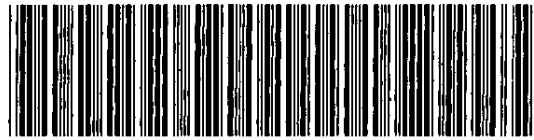

ARTICLES OF ORGANIZATION
OF

The undersigned, acting as an authorized representative of the members of a limited liability company under the Florida Limited Liability Company Act as set forth in Chapter 608 of the Florida Statutes, does hereby adopt the following articles of organization for ACI PROGRESSIVE BILLING SOLUTIONS, LLC (the "Company"):

ARTICLE I

ARTICLE V


INDEMNIFICATION
