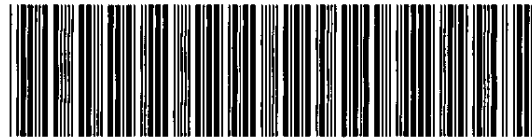

ARTICLE III -- DURATION

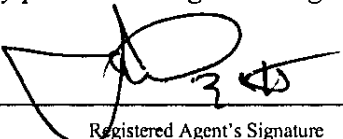

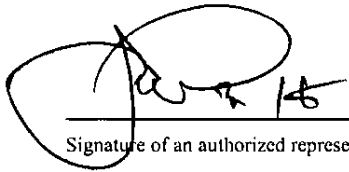
