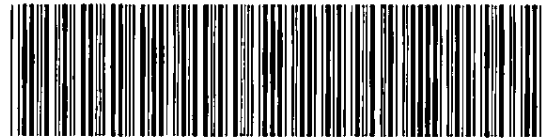

dated October 5, 2020, and any amendments thereto."


