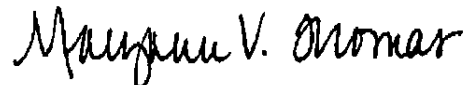

ARTICLES OF DISSOLUTION

THESE ARTICLES OF DISSOLUTION (these "Articles") of KCM SEED COMPANY, LLC, a Florida limited liability company (the "Company"), are submitted this 28th day of September, 2010, in accordance with §608.445 of the Florida Limited Liability Company Act (the "LLC Act").

1. The name of the Company dissolved pursuant to these Articles is:

3. A description of the occurrence that resulted in the Company's dissolution pursuant to §608.441 of the LLC Act was:
