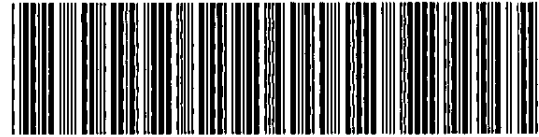

Article 4. - Registered Office & Agent




