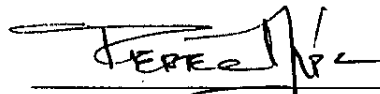

Article VI. Management

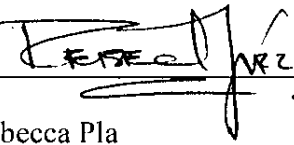
The Company is to be managed by its member or members, and therefore, is a member-managed company.
