**Articles of Organization  
of  
SSD Land Holdings, LLC**

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME**. The name of this limited liability company (the "Company") is **SSD Land Holdings, LLC**.

2. **EFFECTIVE DATE AND DURATION**. The existence of the Company shall commence on September 2, 2008. The period of duration of the Company shall be perpetual.

3. **PURPOSE**. The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.

4. **MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE**. The mailing address and street address of the principal office of the Company is: 201 Center Road, Suite 2, Venice, Florida 34285.


