**ARTICLES OF ORGANIZATION
OF
NASHVILLE INVESTMENT, LLC**

1. NAME. The name of this limited liability company is NASHVILLE INVESTMENT, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 1315 S. Howard Avenue, Tampa, Florida 33606.

3. REGISTERED AGENT AND OFFICE. The name of the initial registered agent of the Company is Preston O. Cockey, Jr. The street address of the initial registered agent of the Company is 110 E. Madison Street, Suite 204, Tampa, Florida 33602.

4. MANAGEMENT OF THE COMPANY. The Company shall be managed by a manager or managers in accordance with the Operating Agreement adopted by all of the members and is, therefore, a **manager-managed** company. The initial managers of the Company are Robert J. Dikman and William B. Hare, Jr.


