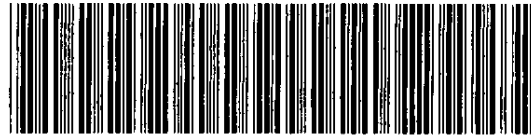


### MEMBERSHIP


