**ARTICLES OF ORGANIZATION
OF
BIRCHWOOD MOBILE ESTATES, LLC**

The undersigned authorized agent of the Initial Members of the limited liability company hereby certifies that the Members, for the purpose of forming a limited liability company under the laws of the State of Florida, provided for the formation, rights, privileges, and immunities of a limited liability company for profit. I further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company shall be BIRCHWOOD MOBILE ESTATES, LLC (the "Company").

**ARTICLE II

MANAGEMENT**

The Company shall be manager-managed in accordance with the Operating Agreement adopted by the initial Member for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law, this Instrument and the Florida Limited Liability Company Act.


