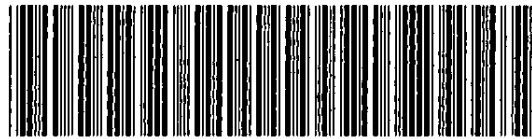

ARTICLE X. RETURN OF CAPITAL


No member shall have the right to demand the return of his or its contribution to capital except as provided in the Company's Regulations then in existence.
